1. In support with the Executive Order No. 26, signed by His Excellency, President Benigno S. Aquino III, all teachers teaching Science and Health, EPP/HELE and HEKASI subjects are required to integrate in their lessons the Coastal Ecosystem Education.
2. This Project aims to:
 - a. provide the pupils/students awareness on the conservation of the coastal ecosystem and marine life for the improvement of the coastal resources;
 - b. make the pupils/students learn to preserve the coastal ecosystem through encouraging them to produce propagules and other seedlings in the school nurseries; and
 - c. involve the pupils/students, teachers, school administrators, stakeholders and other DepEd personnel in mangrove planting along the coastal areas as part of the DepEd's One Billion Tree Project.
