SCHOOL YEAR (SY) 2014-2015"**

1. Attached herewith is Regional Memorandum No. 221, s. 2014, entitled, "Clarification on the Conduct of the English Proficiency Test Relative to DepEd Order No. 14, s. 2014, entitled, "Hiring Guidelines for Teacher-1 Positions effective SY 2014-2015".
2. Special attention is directed to Paragraph 2 of the said memorandum that allows all Divisions to use the English Proficiency Test that was used by their respective Division Selection Committee in the previous year/s.

CLARIFICATION ON THE CONDUCT OF THE ENGLISH PROFICIENCY TEST RELATIVE TO DEPED ORDER NO. 14, s. 2014, ENTITLED "HIRING GUIDELINES FOR TEACHER I POSITIONS EFFECTIVE SCHOOL YEAR (SY) 2014-2015"

TO : All Schools Division Superintendents
Officers-in-Charge of Regular Divisions
School Heads of Public Elementary and Secondary Schools
All Others Concerned

1. Last March 14, 2014, the Department issued DepEd Order No. 14, s. 2014, entitled "Hiring Guidelines for Teacher I Positions Effective School Year (SY) 2014-2015," with the aim of significantly improving professional standards and more effectively providing opportunities for the regularization and absorption of all qualified kindergarten volunteers and LGU-hired teachers into the national plantilla.
2. As stipulated in Section 5.3.8 on Communication Skills of the said Order, an English Proficiency Test shall be distributed by the Central Office and administered by the Division Selection Committee. In consideration of some divisions having already administered the English Proficiency Test to applicants prior to the release of DO No. 14, s. 2014, the Department hereby allows all Divisions to use the English Proficiency Test that was used by their respective Divisions Selection Committees in the previous year/s. This means that the divisions shall no longer wait for the Central Office to distribute the tests and may push through with their original plans/schedules.
3. Nonetheless, all Teacher I items must still be filled by 15 May 2014.
3. Wide dissemination of and strict compliance with this Memorandum is highly desired.
