DATE : 1 April 2014

All heads of departments, agencies and instrumentalities of the national government, including Government-Owned or -Controlled Corporations (GOCCs), State Universities and Colleges (SUCs), and Local Government Units (LGUs), are encouraged to participate in the 2014 Bayani Challenge organized by Gawad Kalinga, which seeks to gather one million volunteers to aid in nation-building efforts for disaster-stricken provinces in the Visayas and Mindanao.

The 2014 Bayani Challenge is a summer event – from 09 April to 12 June – composed of activities such as: building of homes, repair of classrooms, mangrove planting, coastal clean-ups, and health missions. Participants are recommended to choose their respective activities from the summer-long event and volunteer for a total of five (5) days.

Participation of officials and employees is voluntary and shall be subject to existing laws, regulations, and policies. Officials and employees of the different government agencies, GOCCs, SUCs or LGUs who seek to participate in this event are likewise reminded to secure approval from their respective heads prior to participation therein.
