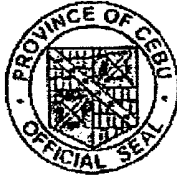

WHEREAS, it has been a common practice by some people to keep and collect new bills and use old and crumpled ones for their purchases and transactions;

WHEREAS, some people scribble their names or numbers on the notes for their own personal reasons while others even framed such bills, thus, putting them totally out of circulation;

WHEREAS, such acts may deem the bills unfit for circulation and destroys the value of the Philippine Peso;

WHEREAS, BSP Regional Director Atty. Berciles mentioned that the proper use of money could add to its value and improve its financial position which in effect could

WHEREAS, such practice on using clean notes is pursuant to BSP Circular No. 61 Series of 1995 entitled "Consolidated Rule and Regulations on Currency Notes and Coins";

WHEREAS, this august Body finds it imperative to request the Department of Education to compel all schools in the province to include the proper handling of money in their curriculum such that they may learn the importance of using clean notes and its impact to the Philippine economy;

WHEREAS, Section 16 of the Local Government Code of 1991 dictates that all Local Government Units should support the enhancement of the economic prosperity of their inhabitants;

NOW, THEREFORE, on motion of Majority Floor Leader/Author, **Hon. ARLEIGH JAY C. SITOY**, duly seconded by Assistant Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, be it

RESOLVED, as it is hereby **RESOLVED**, to request the Department of Education 7 to compel all schools in the province to include the proper handling of money bills in the lessons of school children.
