THREE DAY LIVE – IN TRAINING WORKSHOP ON CHILD PROTECTION POLICY FOR DISTRICT AND SCHOOL GUIDANCE COUNSELORS

**TO: Assistant Superintendents
Education Supervisors/Coordinators
District Supervisors/ OICs
Secondary School Heads**

1. DepEd Order No. 40, s. 2012 known as the “DepEd, Child Protection Policy”, stipulates the Policy and Guidelines on Protecting Children in School from Abuse, Violence, Exploitation, Discrimination, Bullying and other forms of abuse and mandates the conduct of information –dissemination activities and in-service training for teachers on the protection of children in school from abuse, violence, discrimination, bullying, - a peer abuse and related cases.

2. To ensure that all incidents of abuse, violence, exploitation, discrimination, bullying and other similar acts against children are addressed in accordance with the provisions of this Department Order, this Office will conduct a Three Day Live – In Training/Workshop On Child Protection Policy For District And School Guidance Counselors on October 29 – 31, 2014 at DepEd Ecotech Center, Sudlon, Lahug Cebu City.

2. The training aims to:

- capacitate district and school guidance counselors on child protection measures and protocols
- develop strategies to address the risk factors that contribute to the commission of acts of abuse, violence, exploitation, discrimination and bullying
- appreciate the importance of upholding the child's rights

3. Participants to this training are the following:
 - District Guidance Coordinators
 - Central School Guidance Counselors
 - Secondary Lead School Guidance Counselors
4. All participants are expected to be at the venue on Day 1, Wednesday, October 29, 2014. Breakfast will be served as the first meal on day one. Check –out time will be after lunch on Friday, Day 3 – October 31, 2014. Enclosed is the Training Matrix.
5. The training team shall be composed of the school guidance counselors of this Division who were trained in the National Training Of Trainers On Child Protection on August 18-22, 2014 as stated in the Regional Memo No. 405, s. 2014.
6. Expenses like food, venue, training materials and other incidental expenses which will be incurred during this training workshop are chargeable to Division/GAD Funds, while travel expenses of participants and trainers are chargeable to local School MOOE Fund, subject to the usual accounting and auditing rules and regulations.
7. Immediate and wide dissemination of this Memorandum is desired.
