1. This Office is reminding the field of the conduct in the 2016 Supreme Pupil Government (SPG) and the Supreme Student Government SSG) Elections.

2. To synchronize schedule for election related activities, given dates are as follows:

July 08, 2016

- Filing of Certificates of Candidacy

July 11, 2016

- Evaluation of Certificate of Candidacy (COC) vis-à-vis Qualifications and

Disqualifications.

July 12, 2016

- Announcement of the Official List of Candidates

July 18-19, 2016

- Campaign Period: - Presidential Election Forum

- Campus-Wide Presidential and Vice

Presidential Debates

July 20, 2016

- Election Day

July 21, 2016

- Proclamation of Winners

July 25-26, 2016

- Nomination of SPG/SSG Adviser

July 27, 2016

- Oath Taking Ceremony (SSG/SPG Officers and SSG/SPG Advisers)

- 3. All elections conducted before the implementation of this Memorandum shall observe the following:
- a. Candidate who are proclaimed winners of their school's SPG/SSG elections shall retain their elective positions:
- b. On the other hand, School Heads who wish to adopt the additional provisions as stipulated in DepEd Order No. 11, s. 2016 may conduct special elections, particularly for the SSG, in lieu of the introduction of Grade 11 students this school year; and
- c. It is at the discretion of the School Head and the newly elected student government officers whether or not the conduct of a special elections in light of DepED Order No. 11, s. 2012 is necessary.
- 4. Relative to this, schools will furnish this Office with hard copies of the list of newly elected SPG/SSG Officers and SSG/SPG Advisers not later than July 29, 2016, c/o Mrs Rosemary N. Oliverio, Division Coordinator for Araling Panlipunan. Please email the same report to roseoliv2005@yahoo.com
