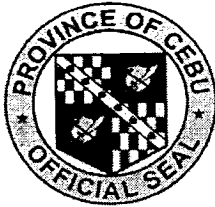

AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

STRONGLY URGING THE DEPARTMENT OF EDUCATION, PROVINCE OF CEBU, TO DISCOURAGE SCHOOLS FROM OPEN BURNING OF SOLID WASTE DURING BRIGADA ESKWELA AND REGULAR CLASS DAYS.

WHEREAS, it is a Constitutional policy of the State provided in Section 16 that, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature";

WHEREAS, Section 48 of the "Ecological Solid Waste Management Act of 2000" prohibits open burning of solid waste;

WHEREAS, as a learning institution that cultivates the young minds, it is proper to practice solid waste management and disposal to inculcate environmental stewardship in the students;

WHEREAS, the protection of the environment is a paramount concern and all departments, agencies and Local Government Units should join the stewardship in protecting our mother earth;

WHEREAS, this august Body expresses its adamant intent to discourage schools from open burning of solid waste through the Department of Education, Province of Cebu's lead;

NOW THEREFORE, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Presiding Officer Pro Tempore, **Hon. JULIAN B. DAAN**, for the approval of the resolution authored by Member, **Hon. MIGUEL ANTONIO A. MAGPALE**, be it

RESOLVED as it is hereby **RESOLVED**, to strongly urge the Department of Education, Province of Cebu, to discourage schools from open burning of solid waste during Brigada Eskwela and regular class days;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of Governor Hilario P. Davide III, the Provincial Information Office, the Department of Education and to all Local Government Units in the Province of Cebu.


