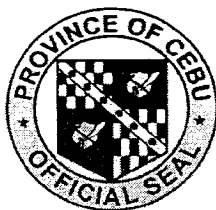

AUTHORIZING THE HON. HILARIO P. DAVIDE III, CEBU PROVINCIAL GOVERNOR, TO EXECUTE AND SIGN, FOR AND ON BEHALF OF THE PROVINCE OF CEBU, A MEMORANDUM OF AGREEMENT (MOA) AMONG THE PROVINCE OF CEBU, DEPARTMENT OF EDUCATION, DIVISION OF CEBU PROVINCE (TUBURAN NATIONAL HIGH SCHOOL), REPRESENTED BY ITS CEBU PROVINCIAL SCHOOLS DIVISION SUPERINTENDENT, DR. RHEA MAR A. ANGTUD AND MUNICIPALITY OF TUBURAN, REPRESENTED BY ITS MUNICIPAL MAYOR, HON. DEMOCRITO M. DIAMANTE, FOR THE CONSTRUCTION OF A TECHNICAL VOCATIONAL TRAINING CENTER IN TUBURAN, CEBU.

WHEREAS, one of the Province of Cebu's mandate is to promote skills through the conduct of Technical Vocational Trainings to marginalized and vulnerable or disadvantaged constituents;

WHEREAS, the Province of Cebu, through its Provincial Social Welfare and Development Office (PSWDO), desires and is willing to partner with DepEd-Tuburan and LGU Tuburan, in implementing social services by allocating P2,000,000.00 for the construction of the Technical Vocational Training Center and another P2,000,000.00 for the equipment, facilities and supplies to be used inside the training center;

WHEREAS, the MOA is necessary to formalize the engagement between the parties on the provision and implementation of various interventions;

WHEREAS, this MOA had been reviewed by the Provincial Legal Office and is found to be equitable among the parties and in line with their respective mandates;

WHEREAS, Section 468 (a) (4) of the Local Government Code of 1991 states that, one of the duties and functions of the Sangguniang Panlalawigan is to approve resolutions/ordinances which shall ensure the efficient and effective delivery of basic services, and in addition, provide for the establishment and operation of vocational and technical schools and similar post-secondary institutions;

NOW, THEREFORE, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Member, **Hon. RAUL D. BACALTOS**, for the approval of the resolution authored by Assistant Majority Floor Leader, **Hon. CHRISTOPHER R. BARICUATRO** and co-authored by Member, **Hon. MIGUEL ANTONIO A. MAGPALE**, be it

RESOLVED as it is hereby **RESOLVED**, to authorize the Hon. Hilario P. Davide III, Cebu Provincial Governor, to execute and sign, for and on behalf of the Province of Cebu, a Memorandum of Agreement (MOA) among the Province of Cebu, Department of Education, Division of Cebu Province (Tuburan National High School), represented by its Cebu Provincial Schools Division Superintendent, Dr. Rhea Mar A. Angtud and Municipality of Tuburan, represented by its Municipal Mayor, Hon. Democrito M. Diamante, for the construction of a Technical Vocational Training Center in Tuburan, Cebu;

RESOLVED FURTHER, to furnish a copy of this Resolution to the Office of the Governor for their reference, information and appropriate action.
