Greetings of peace and hope !



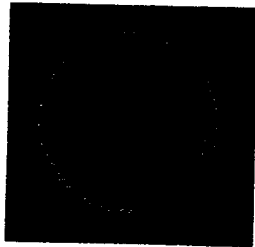
