

RESOLUTION NO. 1899-2016

AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

URGING THE DEPARTMENT OF EDUCATION – REGION VII (DEPED VII) TO INCORPORATE “PEACE EDUCATION” IN THE SCHOOL CURRICULUM.

WHEREAS, Article 14, Sections 1-2 (1) of the 1987 Philippine Constitution provides that, *“the State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all; and shall establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society”;*

WHEREAS, in 2013, the Police Regional Office - VII (PRO-VII) reported that there are groups of men being placed under surveillance for showing signs of becoming private armed groups;

WHEREAS, in 2014, an encounter between the Cebu City Police Office - Special Weapons and Tactics (CPPO-SWAT) Team and the Alimaong group, killed one Alimaong member and injured one police;

WHEREAS, a 2015 report by the Philippine National Police shows a significant increase on the following crimes: *“theft, car theft, physical injuries and rape”*, while the Juvenile Justice and Welfare Council reported that, *“more than eleven thousand (11,000) Filipino children are in contact with the law”;*

WHEREAS, this august Body believes in the importance of incorporating peace education in the school curriculum, so as to open the eyes of the people in the maintenance of peace, and what catastrophe and conflict this can bring to the community;

NOW, THEREFORE, on motion of Majority Floor Leader, Hon. JUDE THADDEUS DURANO SYBICO, duly seconded by Assistant Majority Floor Leader, Hon. CHRISTOPHER R. BARICUATRO and Member, Hon. RAUL D. BACALTOS, for the approval of the resolution authored by Member, Hon. MIGUEL ANTONIO A. MAGPALE, be it

RESOLVED, as it is hereby RESOLVED, to urge the Department of Education – Region VII (DepEd VII) to incorporate “Peace Education” in the school curriculum;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the Governor, Hilario P. Davide III, Provincial Information Office (PIO), and to the Department of Education – Region VII (DepEd VII).
