

**RESOLUTION NO. 147-2017**

**REQUESTING ALL LOCAL GOVERNMENT UNITS, MUNICIPALITIES AND COMPONENT CITIES IN THE PROVINCE OF CEBU, DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) AND THE DEPARTMENT OF EDUCATION (DepEd) TO CONDUCT AND INTENSIFY AN ALL OUT CAMPAIGN AGAINST CHILD LABOR.**

**WHEREAS**, Art. 15, Sec. 3, Par. 2 of the Philippine Constitution declares as a policy "The right of children to assistance including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development;

**WHEREAS**, the Child and Youth Welfare Code (P.D. 603) recognized the child as one of the most important assets of the nation, every effort should be exerted to promote his welfare and enhance his opportunities for a useful and happy life;

**WHEREAS**, the Province of Cebu recognizes that children's rights to protection from abuse, neglect and exploitation are of primary concern;

**WHEREAS**, the problem of child labor continues to grow exponentially. There are 5.59 million child laborers toiling in the Philippines as of 2012 and almost all of them are working in hazardous conditions, according to a survey made by the International Labor Organization (ILO) and the National Statistics Office (NSO);

**WHEREAS**, children are impelled to work from an early age due to poverty and lack of economic opportunities. They must work to help in their family's struggle for survival;

**WHEREAS**, the Department of Education Culture and Sports must promulgate a non-formal education program aimed at promoting the intellectual, moral and vocational efficiency of working children who have not undergone or finished elementary or secondary education.

**WHEREAS**, an all out campaign against Child Labor in the Province of Cebu should be made in coordination with the Department of Labor and Employment (DOLE) and the Department of Education (DepEd). The local government units must participate in monitoring the actual statistics of cases of child labor within their respective units. The local government unit plays an essential role in securing the welfare and provides education on children's rights;

**NOW, THEREFORE**, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Member, **Hon. MIGUEL ANTONIO A. MAGPALE**, for the approval of the resolution authored by Member, **Hon. THADEO JOVITO M. OUANO**, be it

**RESOLVED**, as it is hereby **RESOLVED**, to request all Local Government Units, Municipalities and Component Cities in the Province of Cebu, Department of Labor and Employment (DOLE) and the Department of Education (DepEd) to conduct and intensify an all out campaign against child labor;

**RESOLVED FINALLY**, that copies of this Resolution be furnished to Governor Hilario P. Davide III, all City/Municipal Mayors in the Province of Cebu, Department of Labor and Employment (DOLE) and Department of Education (DepEd), for their information, guidance and appropriate action.
