1. This **Office** hereby informs the field regarding the modifications on the few stipulations of the above-stated memoranda dated **June 1 and 2, 2017** as follows:


1.1 Paragraph One (1) of **Division Memorandum No. 346 s., 2017 dated 01 June 2017** now reads as: "This **Office** announces the conduct of the three-day **Seminar-Workshop on Youth Formation with Gender Awareness Development-Second Batch on June 13-15, 2017** at DepEd Ecotech Center with the partner hotel/service provider, **Hotel Fortuna, Magallanes St., Cebu City**. The training/seminar starts on a **Tuesday** (June 13<sup>th</sup>) and ends on a **Thursday** (June 15<sup>th</sup>). Registration is at **6:00AM-7:30AM** on Tuesday/June 13<sup>th</sup>. The **Opening Program will start at around 8:00AM**. **The first meal/snacks will be served at around 9:00AM on June 13<sup>th</sup>/Tuesday**. (**Crown Regency has been deleted and replaced by the phrase: Hotel Fortuna**).

1.2 Paragraph One (1) of **Division Memorandum No. 350 s., 2017 dated 02 June 2017** now also reads as: "This **Office** announces the conduct of the three-day Seminar-Workshop on Youth Formation with Gender Awareness Development-**Third Batch on June 18-20, 2017** at DepEd Ecotech Center with the partner hotel/service provider, **Hotel Fortuna, Magallanes St., Cebu City**. The training/seminar starts on a **Sunday** (June 18<sup>th</sup>) and ends on a **Tuesday** (June 20<sup>th</sup>). Registration is at **6:00AM-7:30AM** on Sunday/June 18<sup>th</sup>. (**Training date/s, from June 19-21 has been changed to June 18-20 due to multiple activities/trainings handled by the Learning & Development Section/Training Team; the training venue from Crown Regency-Guadalupe has also been changed to Hotel Fortuna, Magallanes St., Cebu City**).

1.3 Paragraph Three (3) of Div. Memo No. 350 s., 2017 is also hereby modified to include the participants from the **Municipalities of Medellin, Madridejos, Borbon and Sogod**. The allocation on the number of participants per school/s districts is based on **the actual number of schools** in the district or municipality. **Primary or extension schools** should be counted separately from the mother school or unit.

2. Other stipulations or provisions on the afore-cited memoranda which are not modified by this **“Corrigendum/Addendum”** remains to be effective and in order.
