The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) with the assistance of schools division and secondary schools personnel, shall administer the **National Career Assessment Examination (NCAE) for the School Year (SY) 2017-2018** from August 30 to 31, 2017 to all Grade 9 students in both public and private schools nationwide. This is pursuant to DepEd Order (DO) No. 55, s. 2016 entitled *Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program* and DO No. 25, s. 2017 entitled *School Calendar for School Year 2017-2018*.
2. The authorized forwarder shall deliver the test materials to schools divisions outside the National Capital Region (NCR) two weeks before the test administration. The same forwarder shall retrieve the test materials one week after the test administration.
