SUBJECT : NON-ACCEPTANCE OF DELIVERY FROM PHILAB  
INDUSTRIES, INC.

The Department of Education (DepEd) contracted Philab Industries, Inc. joint venture with China Educational Instrument and Equipment Corporation (CEIEC) to mass produce, supply, and deliver Science and Mathematics equipment and cabinets to public elementary schools nationwide.

However, it has been observed that the mentioned supplier is delivering the contracted goods without totally complying their contractual obligation for the following reasons:

- most of the goods did not undergo the pre-delivery inspection by the national inspectorate;
- there are goods that failed during the conduct of the pre-delivery inspection which might be delivered by the supplier; and
- the goods that failed during pre-delivery inspection, which can be easily identified since no QC PASSED sticker was attached.

In this connection, you are hereby directed not to accept deliveries of the contracted goods delivered by the mentioned supplier.

Immediate dissemination of and strict compliance with this Memorandum is directed.
