

2. This year's edition shall showcase our pupils and students' talents in the contest categories listed below:

3. Only the First Placers in the district/municipal level are qualified for the Cluster Level competition, while the Top Six Winners in the Cluster Level shall qualify for the Division Level. Contest guidelines used during the SY 2016-2017 for both elementary and secondary levels shall still take effect, except for Spelling Bee, as it shall be open only to pupils and students in public schools.
4. A registration fee of **Fifty Pesos (Php 50.00)** shall be charged each contestant in the Cluster Level, while it is **One Hundred Pesos (Php 100.00)** for every contestant and coach in the Division Competition to defray the cost of decoration, certificates, contest materials, trophies and medals.
5. Transportation expenses, meals and registration of participants shall be charged to **Local School MOOE/PTA or any other source of funds**, subject to their availability and the usual accounting and auditing rules and regulations.
6. This Memorandum also serves as the participants' **Authority to Travel**.
7. Immediate and wide dissemination of this Memorandum to all concerned is directed.
